The Stewards, having received a report from the Clerk of the Course (document n°3.4), having also examined a document from the GPS provider (VDS Racing), summoned and heard the driver and competitor n°88, Jacques-Alain BERNARD (summons No 1), have considered the following matter, determine the following:

Driver and car No: 88

Competitor: Jacques-Alain BERNARD

Day and Time (fact): 19/05/2022 at 16:15h

Session: Reconnaissances

Fact: The competitor did the reconnaissance for ES3/6 and ES2/5 on 19/05/22. Additionally, the GPS for reconnaissances was not connected.

Offence: Breach of Articles 9.1, 9.7 and Appendix II of the Supplementary Regulations, articles 12.2.1.i, 12.4.1.c, and 12.8.1 of the ISC and RRSR's at. 35.4.2.

Decision: Fine of 1100 Euro

Reason: Having considered the matter extensively, the Stewards determined that the competitor collected his GPS for reconnaissance on 18/05/2022, but it was never installed in the recce car.

On 19/05/2022 at 16h15, a marshal on the road stopped the crew in ES 2/5 for an alleged excessive speed in the village of Aiglun, when this ES was supposed to be driven only on 18/05/2022.

Later on, another marshal at the finish of the ES 3/6 stopped the crew, and again this ES was supposed to be driven only on 18/05/2022.

The competitor declare that he has a new codriver without experience and they were not aware of the reconnaissance schedule. They only performed reconnaissance on 19/05/2022 because they could not do it the day before due to their respective jobs. They forgot the GPS in the racing car when they rush to the special stages for reconnaissance.

In accordance with Article 12.7 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
